The SAVE THE FROGS! website (www.savethefrogs.com) has educated millions of visitors worldwide about amphibians. In 2018 we continued developing the site by adding 47 articles about amphibians and ways to save them from extinction. We also launched a learning management system with 50 educational lessons, including 10 hours of video tutorials and presentations.

Presentations

In 2019, SAVE THE FROGS! Founder Kerry Kriger gave 21 educational presentations in four countries (India, Bangladesh, Ecuador and Portugal), directly reaching over 2,600 attendees.
